\*\*\* In Institutional Total Quota= 25% out of this 15% Quota given to SC UT Chandigarh Candidate i.e. 0.37 seats ----So, No Seat Can be offered in this year to SC Chandigarh Candidate, it may be filled in next years.

\*\*\*\* In SC 15% Reserved for Chandigarh, UT Candidates comes to 1.5 seats so in this year filled 1 seat remaining .5 seats (half seat) will be filled in next year.

**The benefit of reservation will be given as per Clause 12 (I) of State Govt. Notification No. 1/6/2019-HB-II dated Chandigarh the 09.12.2021 regarding procedure for admission to MD/MS (Ayurveda) courses in Participating College(s) for Academic Session 2021-22. The clause is reproduced as under:**

**“I. Benefit of reservation will be given to all the reserved categories upto 3<sup>rd</sup> counselling according to the Haryana State reservation policy. In case at the time of 3rd counselling the reserved seats of various categories remain vacant and no eligible candidates of the reserved categories are available then these vacant seats may be thrown open to Haryana Open General Category.”**
